Ortolano, L. Parker 77 Motions	Fode Niang	Charged with Attempted Murder and additional charges. The defendant allegedly slashed a man with a box cutter outside of a store on East 161 st Street on June 20, 2024.

Disla, A. Stone 27 Motions	Christian Valdez	Charged with second-degree Attempted Murder and additional charges. On December 20, 2023, the defendant allegedly stabbed Carmen Velez and her daughter with a knife in their East Tremont Avenue apartment and threatened to throw the girl off the fire escape.

Baughman, R. Stone 27 Sentencing	Michael Ramos	Pleaded guilty to two counts of second-degree Assault. The defendant beat and starved a 14-year-old girl and her 13-year-old brother while living with him in his Eastchester Gardens apartment.
Baughman, R. Michael 27 COC	Tajahnae Brown	Charged with Attempted Assault in the first degree, second-degree Assault, and additional charges. The defendant allegedly caused her young daughter to become ill by giving her an overdose of prescription medication to treat epilepsy.

Pucha, J. -- SCA Appearance	Tony Smith	Charged with first-degree Gang Assault and additional charges. The defendant, an inmate at Rikers Island, acting in concert with three other inmates, allegedly slashed another inmate's face on March 17, 2024.
Dicostanzo, N. Morales 96 COC	Rashawn Pough	Charged with second-degree Murder and additional charges. The defendant, acting in concert with another, allegedly shot and killed Courtney Howell on November 19, 2023, near 1780 Grand Concourse
Castro, A. Collins 19 COC	River Jones Allan Algarin Isiah Garrett	Charged with first-degree Murder and additional charges. The defendants, in concert with each other, allegedly shot Avanti Frowner on June 9, 2022, leading to his death.
Scaccia, C. Collins 19 Hearing	Vernon Gowdy	Charged with second-degree Murder and additional charges. On July 30, 2022, the defendant allegedly stabbed Kenneth Fair to death with a knife.

Scaccia, C. Fabrizio 18 Appearance	Gregory Fleetwood	Charged with second-degree Murder. The defendant allegedly strangled a pregnant woman in 1996, leading to her death.
Ekanayake, N. Fabrizio 18 Motions	Marquise Webb Brian Innocent	Charged with first-degree Assault and additional charges. The defendants allegedly attacked a NYPD officer on a northbound #1 train at 238 th Street on November 11, 2023. The officer, who was trying to make an arrest, suffered a serious eye injury.
Lopez, R. Parker 77 COC	Victor Matos	Charged with second-degree Kidnapping and additional charges. The defendant allegedly stole a vehicle on June 16, 2024, that was parked with the engine running on East 146 th Street with child in the backseat.
White, C. Steed 71 Motions	Waynol Recio Dreshawn Lucas	Charged with two counts of Attempted Murder and additional charges. On July 16, 2024, at approximately 10:00 p.m., the defendants acting in concert allegedly shot two boys, ages 12 and 13, inside a McDonalds on White Plains Road.
