The defendant allegedly supplied a gun to a co-defendant who fired at least 13 times into a crowd at the Pelham Parkway Houses on September 9, 2022. Four bystanders were shot.  |
| Jamelo, S.<br>Goldberg<br>77<br>Motion          | Sheydon McLean<br>Orville Berry | Charged with second-degree Manslaughter and Criminally Negligent Homicide. The defendants allegedly caused the death of Dwight Downer by each running a redlight in their vehicles, crashing and then sending one car into Downer, fatally injuring him, at Eastchester Road and Givan Avenue on November 30, 2024. |

The defendant sexually assaulted a female relative for three years starting when she was 13 years old. |
