ADA Judge Part # Status	Defendant Name	Case Details
Miller, K. Clancy 28 Trial	Grei Mendez Felix Herrera Garcia	Charged with second-degree Murder and additional charges. On September 15, 2023, the defendants acting in concert, allegedly caused the death of 22-month-old Nicholas Dominici through exposure to fentanyl in her home daycare center.
Miras, J. Stone 27 Trial	Joseph Martinez AKA Jupiter Joe	Charged with second-degree Murder. The defendant allegedly killed 13-year-old Minerliz Soriano. The victim's body was found in a dumpster in Co-Op City on February 28, 1999. The victim had been sexually abused, and her neck was compressed causing her death. DNA led to his arrest in 2021.

McDonald, S. Collins 19 Sentencing	Ernst Delma	Pleaded guilty to second-degree Assault. On August 8, 2024, the defendant hit an NYPD Officer in the face with a liquor bottle and severely cut her upper lip in front of 1745 Randall Avenue in the Clason Point section.

DiCostanzo, N. Rodriquez- Morrick 29 Hearing on a Motion	Lawrence Hyde	Found guilty of second-degree Murder, not yet sentenced. On September 7, 2021, the defendant stabbed Cori Lowe, 31, in the heart. He then posted a picture of the lifeless victim on his Facebook page.
Dolan, M. -- SCA Appearance	Waldo Mejia	Charged with second-degree Murder and additional charges. The defendant allegedly fatally stabbed 14- year-old Caleb Rijos at a bus stop by Alexander Avenue and 138th Street in the Mott Haven Section on January 10, 2025.

Guzman, J. Busching 14 Sentencing	Akeem Lee	Found guilty of 2 counts of Sex Trafficking, second-degree Intimidating a Witness, third-degree Intimidating a Witness and Endangering the Welfare of a Child. Between August 2019 through November 2022, the defendant, acting in concert, sex trafficked 16 girls and young women. Out of the 16, seven were underage. Their operation was located at the 7 Days Hotel located at 2338 Bruckner Boulevard.
Collins, T. Clancy 28 COC	Benjamin Lozovsky	Charged with second-degree Murder and additional charges. The defendant allegedly killed Jacklyn Timinski by hitting her in the head with a kettlebell inside an apartment at 1431 Shore Drive in the Throggs Neck section on September 8, 2024.
Miras, J. Rosenblueth 31 Sentencing	Edison Cruz	Found guilty of first-degree Manslaughter and two counts of second-degree Criminal Possession of a Weapon. The defendant shot and killed David Scott and wounded two

		bystanders after an argument inside a Taco Bell on Jerome Avenue on May 3, 2022.
Miras, J. Clancy 28 Appearance	Jayden Rivera	Charged with first-degree Murder and additional charges. The defendant allegedly stabbed to death his father, his father's girlfriend, and their 5-year-old son inside an apartment at 674 East 138th Street in the Mott Haven section on November 26, 2023.
Suminski, G. Clancy 28 Appearance	Shaun Pyles	Charged with second-degree Murder and first-degree Manslaughter. The defendant allegedly stabbed Tyquan Person to death with a knife inside 808 Elsmere Place in the Tremont section on March 24, 2023.
Taverna, R. Park 77 Appearance	Timothy Bohler	Charged with first-degree Assault and additional charges. The defendant allegedly swung a machete and cut off four fingers of a man who was defending his dog inside a bodega on East 178th Street on January 24, 2025.
Dolan, M. Yearwood TRP Appearance	Christopher Hunt	Charged with second-degree Murder and additional charges. The defendant allegedly killed Eric Worell by slashing him in the throat after an argument inside 237 Landing Road on May 26, 2024.

Wichman, T. Stone 27 COC	Gloria Asamoah	Charged with first-degree Murder and additional charges. The defendant allegedly asphyxiated her five-year-old twins on December 18, 2023.

Vargas, J. Stone 27 COC	La'Keysha Jackson	Charged with second-degree Assault and additional charges. The defendant provided home care services for a family and was allegedly caught on camera whipping a six-year-old and a four-year-old with a belt dozens of times between April and May of 2025.
Newell, S. Stone 27 COC	Lynija Eason	Charged with second-degree Murder and additional charges. The defendant allegedly caused the death of her 6-year-old daughter by hanging her by her wrists in a closet and repeatedly striking her with a hard object.

Castro, A. Fabrizio 18 Appearance	Skydajah Patterson	Charged with second-degree Murder and additional charges. The defendant allegedly struck her mother on the head with a pot, killing her inside 720 Westchester Avenue on March 25, 2024.
Pucha, J. Fabrizio 18 Motion	Sundance Oliver	Charged with Attempted Murder in the second-degree and additional charges. The defendant allegedly slashed two Correction Officers with a scalpel, one across the face, the other across his skull on August 25, 2025, while he was an inmate at Rikers Island.
