Monday, September 22, 2025		
ADA Judge Part # Status	Defendant Name	Case Details
Aradhya, N. Lewis 70 Sentencing	Anibal Colon	Pleaded guilty to Attempted Assault in the first-degree. The defendant opened fire on the street on Third Avenue in Mott Haven. A bullet shattered a window of an MTA bus, injuring two passengers on July 1, 2023.
Doty, E. Morales 96 COC	Jamar Banks	Charged with Attempted Murder in the second degree and additional charges. The defendant allegedly stabbed an off-duty MTA cleaner multiple times at the Pelham Bay station on January 2, 2025.
Dolan, M. Park 77 Motion	Terrell Loyd	Charged with second-degree Murder and additional charges. The defendant allegedly shot and killed Laquai Dash on the grounds of P.S. 157 on March 7, 2025.
Milanes, M. Park 77 COC	Windella Sanderson Wells	Between September 1, 2019, and May 1, 2023, the defendant allegedly posed as an attorney who could improve citizenship applications, taking \$73,000 from members of the Caribbean community.

Miller, K. Clancy 28 Trial Opening	Grei Mendez	Charged with second-degree Murder and additional charges. On September 15, 2023, the defendant acting in concert, allegedly caused the death of 22-month-old Nicholas Dominici through exposure to fentanyl in her home daycare center.
Ambrosi, A. -- SCA Appearance	Chris Alicearodriguez	Charged with Operating as a Major Trafficker and additional charges. The defendant allegedly picked up a redirected package containing 11 kilos of cocaine from a store in the Bronx after it was detected at JFK by Customs and Border Control.
Uy, E. --- SCA Appearance	Sundance Oliver	Charged with Attempted Murder in the second-degree and additional charges. The defendant allegedly slashed two Correction Officers with a scalpel, one across the face, the other across his skull on August 25, 2025, while he was an inmate at Rikers Island. The defendant also faces charges for tossing feces at Correction Officers.

ADA Judge Part # Status	Defendant Name	Case Details
Miras, J. Clancy 28 Hearing	Romel Jarrett Terrence Downes	Charged with second-degree Murder and first-degree Manslaughter. On September 12, 2024, the defendants, acting in concert, fatally beat fruit vendor Leslie Sanchez with a baseball bat on Fordham Road.
Miras, J. McCormack 22 Hearing/Trial	Sh-ward Bee	Charged with second-degree Murder and additional charges. The defendant allegedly killed Stefon Barnes with a stray bullet on March 31, 2024, after an attempted gunpoint robbery at a bodega on Townsend Avenue.

Taverna, R. Park 77 Possible Disposition	Timothy Bohler	Charged with first-degree Assault and additional charges. On January 24, 2025, the defendant allegedly swung a machete and cut off four fingers of a man who was defending his dog inside a bodega on East 178 th Street.

ADA Judge Part # Status	Defendant Name	Case Details
Disla, S. Stone 27 Possible Disposition	Christian Valdez	Charged with Attempted Murder in the second-degree and additional charges. On December 20, 2023, the defendant allegedly stabbed Carmen Velez and her daughter with a knife and threatened to throw the girl off the fire escape at their East Tremont Avenue apartment.
Newell, S. Stone 27 Sentencing	Damion Comager	Pleaded guilty to first-degree Manslaughter. The defendant shook his three-month-old daughter to death and disposed of her body in the woods near the Major Deegan and West 161 st Street in the Highbridge section.
Lindston, R. Morales 96 Motion	Rusnelly Clase Lisa Gereldino Justin Echevarria	Charged with first-degree Corrupting the Government and additional charges. The defendants allegedly filed fraudulent vendor invoices through the New York City School system netting them \$165,000.

ADA Judge Part # Status	Defendant Name	Case Details

Dicostanzo, N. Morales 96 Motion	Alfredo Trinidad Betty Cotto Justin Herde	Charged with Second-degree Murder and additional charges. The defendants, acting in concert, allegedly shot, and killed William Alvarez on the D train at Grand Concourse and East 182nd Street on February 23, 2024.
Davis, J. Collins 19 Sentencing	Anthony Taveras- Morales	Pleaded guilty to second-degree Assault. The defendant lit a fire in his cell and then slashed two responding Correction Officers while incarcerated at Rikers Island on December 17, 2024.
Miras, J. Stone 27 Trial Opening	Joseph Martinez AKA Jupiter Joe	Charged with second-degree Murder. The defendant allegedly killed 13-year-old Minerliz Soriano. The victim's body was found in a dumpster in Co-Op City on February 28, 1999. The victim had been sexually abused, and her neck was compressed causing her death. DNA led to his arrest in 2021.

ADA Judge Part # Status	Defendant Name	Case Details
Carter, J. Mitchell 11 COC	Bryan Ciprian	Charged with second-degree Murder, first-degree Robbery, and additional charges. The defendant while allegedly committing a robbery, shot, and killed Edgar Acevedo Arenas on February 18, 2024, near East Kingsbridge Road and the Grand Concourse.
Ambrosi, A. Steed 71 Motion	Charles Vilson Elizabeth Allen Marlon Laronde	Charged with first-degree Criminal Sale of a Firearm and additional charges. The defendants acting in concert allegedly purchased guns from out-of-state, brought them to a Bronx autobody shop, and removed the serial numbers. Seventeen firearms were sold to an undercover police officer.
