Tripp, K. Morales 96 Appearance	Frank Blackshear	Charged with second-degree Grand Larceny, and additional charges. The defendant allegedly transferred property of an elderly victim to himself by using a fraudulent property deed.

Collins, T. Isales 77 Motion	Ahmet Gashi	Charged with second-degree Murder and additional charges. On December 31, 2006, after being ejected from a bar, the defendant allegedly got into his car and ran over Kemal Kolenovic. The defendant fled to Kosovo and was extradited to the U.S. on December 13, 2024.
Barker, G. Clancy 28 Appearance	Corey Henry Travis Laroc	Charged with Attempted Murder in the second-degree and additional charges. The defendants, acting in concert, allegedly slashed and stabbed another inmate on Rikers Island on August 3, 2023.
Strout, N. Morales 96 COC	Emmanuel Awah Elias Afflada	Charged with Attempted Murder in the second-degree and additional charges. On January 1, 2024, the defendants acting in concert, allegedly stabbed a man

		after he wished them a Happy New Year at the 182nd Street subway station.
<b>Doty, E. Morales 96 Motion</b>	<b>Jamar Banks</b>	Charged with Attempted Murder in the second-degree and additional charges. On January 2, 2025, the defendant allegedly stabbed Omar Oquendo multiple times with a knife. The victim, an off-duty MTA cleaner, was on the northbound No. 6 train platform at Pelham Bay station.
<b>Gibson, T. Isales 77 Motion</b>	<b>Omar Habib</b>	Charged with second-degree Strangulation and additional charges. On July 29, 2023, the defendant, an NYPD officer, allegedly placed an illegal chokehold on someone he was arresting causing the man to lose consciousness.
<b>Baughman, R. Busching 14 Appearance</b>	<b>Papa Diop</b>	Charged with first-degree Rape and additional charges. On August 5, 2024, the defendant allegedly approached a woman near 149th Street and Bergen Avenue and then raped her.
<b>Wichman, T. Busching 14 Motion</b>	<b>Ishmael Francis</b>	Charged with second-degree Rape and additional charges. On September 18, 2024, the defendant allegedly raped a 13-year-old boy in the stairwell of the Sotomayor Houses.

<b>ADA Judge Part #</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Kamens, E. Lewis 70 COC</b>	<b>Brittany Ward Aaron Rene</b>	Charged with second-degree Murder and additional charges. The defendants acting in concert with each other allegedly shot Marquis Lane on February 7, 2023, leading to his death. The shooting occurred near Park Ave, and E. 167 <sup>th</sup> Street.
<b>Evans, S. David DVM Appearance</b>	<b>Dana Barschdorf</b>	Charged with Endangering the Welfare of a Child and additional charges. On January 14, 2025, during a gym class, the defendant, a P.E. teacher at a public school supervising a special needs class, allegedly exposed himself to students.

<b>Dolan, M. Morales 96 COC</b>	<b>Melvin Arias</b>	Charged with second-degree Murder and additional charges. On April 29, 2024, the defendant allegedly killed his mother with a sharp object inside an apartment on the Grand Concourse near 156th Street.
<b>Pucha, J. Collins 19 COC</b>	<b>Moussa Cisse</b>	Charged with second-degree Assault, and additional charges. On January 24, 2023, the defendant allegedly assaulted two Correction Officers at Rikers Island resulting in one receiving a concussion and the other to suffer substantial head pain.
<b>Sizemore, J. Morales 96 Motions</b>	<b>Kenny Victoria</b>	Charged with Attempted Offering a False Instrument in the first-degree, second-degree Assault, and additional charges. The defendant, an NYPD Officer, allegedly falsified an accident report in one incident, and hit a person on the head with his radio during an arrest which required stitches.
<b>Miras, J. McCormack FYP 32 Sentencing</b>	<b>Matthew Godwin Omar Bojang</b>	Defendants pleaded guilty in the fatal shooting of 11-year-old Kyhara Tay, killed while they were aiming for a 13-year-old boy on Westchester Avenue on May 16, 2022.

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Dicostanzo, N. Morales 96 COC</b>	<b>Alfredo Trinidad Betty Cotto Justin Herde</b>	The defendants are charged with second degree Murder and additional charges for the alleged fatal shooting of William Alvarez on the D train at Grand Concourse and East 182nd Street on February 23, 2024.
<b>Nunez, V. -- SCA Appearance</b>	<b>Casmine Aska</b>	Charged with Predatory Sexual Assault Against A Child and additional charges. On February 27, 2025, the defendant allegedly assaulted a 15-year-old girl in a Co-op City elevator then allegedly dragged her to a stairwell and raped her.

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Martin, M. Isales 77 Motion</b>	<b>Antonio Romero</b>	Charged with first-degree Assault and additional charges. On December 17, 2024, the defendant allegedly slashed a female victim across the face with a knife inside the subway station at East 149 <sup>th</sup> Street and the Grand Concourse.
<b>Ambrosi, A. Steed 71 Motions</b>	<b>Marlon Laronde Elizabeth Allen</b>	Charged with first-degree Criminal Sale of a Firearm and additional charges. The defendants, acting in concert, between June 21, 2023, and April 24, 2024, allegedly purchased guns from out-of-state, brought them to a Bronx autobody shop and removed the serial numbers. Seventeen firearms were allegedly sold to an undercover police officer.
<b>Dicostanzo, N. Fabrizio 18 Motion</b>	<b>Dante Williamson</b>	Charged with second-degree Murder and additional charges. The defendant acting in concert with another, allegedly shot and killed Courtney Howell on November 19, 2023, near Morris Avenue and E. 174 <sup>th</sup> Street.
<b>Namani, B. Clancy 28 Motion</b>	<b>Diego Ortega</b>	Charged with second-degree Murder and additional charges. The defendant allegedly stabbed Baraquiel Castelan to death with a knife on February 3, 2024, after the two got into an argument on East 153rd Street.
<b>Ekanayake, N. Fabrizio 18 Motion</b>	<b>Marquise Webb Brian Innocent</b>	Charged with first-degree Assault and additional charges. The defendants allegedly attacked a NYPD officer on a No. 1 train at 238th Street on November 11, 2023. One of the officer's eyes was damaged in the attack.
<b>Taverna, R. Isales 77 Motion</b>	<b>Timothy Bohler</b>	Charged with first-degree Assault and additional charges. On January 24, 2025, the defendant allegedly swung a machete at a man and cut off four of his fingers as the victim was defending his dog.
