ADA Judge Part # Status	Defendant Name	Case Details
Carter, J. McCormack 22 Appearance	Anyelo Velez Rodriguez	Charged with second-degree Manslaughter and additional charges. The defendant on February 11, 2019, allegedly crashed his BMW into a vehicle pileup on the Cross Bronx Expressway, killing two people, a good Samaritan assisting with the accident, and another driver.
Bartlett, K. Clancy 28 COC	Steven Hutchinson	Charged with Attempted Murder in the second degree and additional charges. The defendant allegedly struck another inmate across the face with a sharp object on Rikers Island and threatened to cut a Correction Officer, on December 28, 2023.
Rosen, J. Isales 77 Appearance	Angel Mendez Alexandra Penavallejo Victor Martinez	Charged with first-degree Robbery and additional charges. On March 5, 2024, the defendants, acting in concert, allegedly stole \$100,000 worth of jewelry from a store on Fordham Road during which they displayed a handgun.

<b>ADA Judge Part #</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Disla, S. Stone 27 COC</b>	<b>Christian Valdez</b>	Charged with Attempted Murder in the second-degree and additional charges. On December 20, 2023, the defendant allegedly stabbed Carmen Velez and her daughter with a knife in their East Tremont Avenue apartment and threatened to throw the girl off the fire escape.
<b>McDonald, S. Isales 77 COC</b>	<b>Ernst Delma</b>	Charged with Aggravated Assault Upon a Police Officer or a Peace Officer and additional charges. On August 8, 2024, the defendant allegedly hit an NYPD Officer in the face with a liquor bottle.
<b>Dicostanzo, N. Rosenblueth 31 Sentencing</b>	<b>Kadeem Edwards</b>	Found guilty of second-degree Murder and additional charges. The defendant, acting in concert with three unapprehended individuals, shot and killed Jonathan Pena after stealing his necklace on November 13, 2021, on Macombs Avenue.
<b>Kline, A. Stone 27 COC</b>	<b>Rosvin Mejia Castillo</b>	Charged with second-degree Murder, Attempted Murder in the second degree, and additional charges. The defendant allegedly shot and killed his girlfriend Saida Xiomara Bonilla in her apartment and wounded a teen and a 9-year-old boy who were visiting relatives, on February 10, 2024.
<b>Sannicandro, R. Steed 71 Motion</b>	<b>Isaac Garcia Kyshawn Johnson</b>	Charged with Attempted Murder in the second degree and additional charges. On September 9, 2022, defendant allegedly supplied a gun to a co-defendant who went to the Pelham Parkway Houses and allegedly fired at least 13 times into a crowd. Four innocent bystanders were shot.
<b>Commelin, C. Park 77 COC</b>	<b>Michael Stewart</b>	Charged with Attempted Murder in the second-degree and additional charges. On September 2, 2024, the defendant, an off-duty parole officer, was at the Kutty Bar and Lounge when a patron allegedly shot a man in the leg. The defendant allegedly fired his gun at that man before fleeing. Other individuals allegedly lied about the incident to police and tampered with evidence

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Ortolano, L. Isales 77 Appearance</b>	<b>Fode Niang</b>	Charged with Attempted Murder and additional charges. The defendant allegedly slashed a man with a box cutter outside of a store on East 161st Street on June 20, 2024.
<b>Commelin, C. Isales 77 COC</b>	<b>Freddy Flores</b>	Charged with Attempted Murder in the second-degree and additional charges. On the afternoon of March 30, 2024, on East Fordham Road, the defendant allegedly fired a gun five times from across the street. A stray bullet struck a 2-year-old boy in the left hip.
<b>Barker, G. Morales 96 COC</b>	<b>Tymirh Bey-Foster</b>	Charged with two counts of second-degree Assault and additional charges. On April 7, 2024, the defendant allegedly assaulted a Correction Officer at Rikers Island leaving her unconscious with broken bones in her face.
<b>Lopez, R. Isales 77 COC</b>	<b>Victor Matos</b>	Charged with second-degree Kidnapping and additional charges. The defendant allegedly stole a vehicle on June 16, 2024, that was parked with the engine running on East 146th Street with a child in the backseat.
<b>White, C. Steed 71 Motion</b>	<b>Wayno Recio Dreshawn Lucas</b>	Charged with two counts of Attempted Murder and additional charges. On July 16, 2024, at approximately 10:00 p.m., the defendants acting in concert allegedly shot two boys, ages 12 and 13, inside a McDonalds on White Plains Road.
<b>Leo, M. -- SCA Appearance</b>	<b>Ramon Reyes</b>	Charged with first-degree Murder and additional charges. On April 6, 2025, the defendant allegedly broke into the home of his children's mother and stabbed her multiple times. He then allegedly stabbed their grandmother to death while the children were present.

<b>Scaccia, C. Fabrizio 18 Appearance</b>	<b>Gregory Fleetwood</b>	Charged with second-degree Murder. The defendant allegedly strangled Jasmine Porter, a pregnant woman in 1996, leading to her death. He was arrested on August 8, 2022. The investigation matched DNA evidence using technology not previously available.
<b>Lindston, R. -- SCA Appearance</b>	<b>Rusnelly Clase Luisa Dessus Cruz Justin Echevarria Lisa Michell Geraldino</b>	Charged with first-degree Corrupting the Government and additional charges. The defendants allegedly filed fraudulent vendor invoices through the New York City School system netting them \$165,000.
