| ADA Judge Part # Status | Defendant Name | Case Details |
| Martin, M. Park 77 Motion | Antonio Romero | Charged with first-degree Assault and additional charges. On December 17, 2024, the defendant allegedly slashed a female victim across the face with a knife inside the subway station at East 149th Street and the Grand Concourse in the Concourse Village section. |
| Arning, T. Morales 96 Motion | Biyagi Jawara Ebarama Jawara Mohammed Kamar | Charged with Attempted Murder in the second-degree and additional charges. On January 8, 2025, the defendants acting in concert, allegedly shot at a group of people in front of 239 East Tremont Avenue. |
| Kline, A. Stone 27 Motion | Junior Perez Diaz | Charged with second-degree Murder and additional charges. On March 2, 2025, the defendant allegedly killed Pamela Alcantara inside an apartment on Morris Avenue and placed her body inside a suitcase and left it near the Saw Mill River Parkway in Yonkers. |
| Grading, J. McCormack 22 Sentencing | Kenny Urbaez | Found guilty of second-degree Criminal Possession of a Weapon. On May 25, 2028, the defendant fired several shots near 2256 Walton Avenue in the Fordham Heights section. No one was injured. |

| Dolan, M. Morales 96 Motion | Melvin Arias | Charged with second-degree Murder and additional charges. On April 29, 2024, the defendant allegedly killed his mother with a sharp object inside an apartment on the Grand Concourse near 156th Street. |
| Barker, G. Morales 96 Appearance | Tymirh Bey-Foster | Charged with two counts of second-degree Assault and additional charges. The defendant, on April 7, 2024, allegedly assaulted a Correction Officer at Rikers Island leaving her unconscious with broken bones in her face. |
| Davis, J. Yearwood TRP Appearance | Anthony Taveras-Morales | Charged with second-degree Arson, second-degree Assault, and additional charges. On December 17, 2024, the defendant, who is incarcerated at Rikers Island, allegedly lit a fire in his cell. He then allegedly slashed two responding Correction Officers. |
| Carter, J. Park 77 Motion | Herman Gayle | Charged with second-degree Murder, first-degree Manslaughter, and additional charges. On September 29, 2024, the defendant allegedly shot and killed Devonte Serrano. |

| Carter, J. McCormack 22 Appearance | Anyelo Velez Rodriguez | Charged with second-degree Manslaughter and additional charges. The defendant on February 11, 2019, allegedly crashed his BMW into a vehicle pileup on the Cross Bronx Expressway, killing a good Samaritan assisting with the accident, and another driver. |

| <p>Nunez, V. -- SCA Appearance</p> | <p>Casmine Aska</p> | <p>Charged with Predatory Sexual Assault Against A Child and additional charges. On February 27, 2025, the defendant allegedly assaulted a 15-year-old girl in a Co-op City elevator then allegedly dragged her to a stairwell and raped her.</p> |
| <p>Vega, J. Morales 96 Motion</p> | <p>Kayjon Yizar</p> | <p>Charged with second-degree Murder and additional charges. On December 24, 2024, the defendant allegedly approached Arkmayer Davis in front of 101 East Tremont Avenue and stabbed him to death.</p> |
| <p>Russo, S. Steed 71 COC</p> | <p>Kyshawn Johnson</p> | <p>Charged with Attempted Murder in the second degree and additional charges. On September 9, 2022, Johnson was told by a co-defendant to retrieve a gun. After he delivered the gun, the co-defendant allegedly went to the Pelham Parkway Houses in the Pelham Gardens section and fired at least 13 times into a crowd. Four innocent bystanders were shot.</p> |
| <p>Bartlett, K. Clancy 28 Hearing/Trial</p> | <p>Steven Hutchinson</p> | <p>Charged with Attempted Murder in the second degree and additional charges. The defendant allegedly struck another inmate across the face with a sharp object on Rikers Island and threatened to cut a Correction Officer, on December 28, 2023.</p> |
| <p>Villaverde, M. Bowen 17 Sentencing</p> | <p>Victor Ramos</p> | <p>Pleaded guilty to second-degree Vehicular Manslaughter. The defendant while driving impaired by marijuana, fatally struck a 67-year-old man on September 5, 2023, as he was crossing Castle Hill Avenue and Turnbull Avenues in the Castle Hill section.</p> |

| Vega, J. Lewis 70 Motion | Lillibeth Vasquez | Charged with second-degree Murder and first-degree Manslaughter. On November 26, 2023, near Intervale Avenue and Fox Street in the Longwood section, defendant allegedly crashed her vehicle into Robert Jimenez, who was on a scooter, causing his death. |
| Castro, A. Fabrizio 18 COC | Skydajah Patterson | Charged with second-degree Murder and additional charges. On March 25, 2024, inside 720 Westchester Avenue, the defendant allegedly struck her mother on the head with a pot, killing her. |
