Rosen, J. Isales 77 Appearance	Angel Mendez Alexandra Penavallejo Victor Martinez	Charged with first-degree Robbery and additional charges. On March 5, 2024, the defendants, acting in concert, allegedly stole \$100,000 worth of jewelry from a store on Fordham Road during which they displayed a handgun.

Wichman, T. Busching 14 COC	Derick Colon	Charged with Predatory Sexual Assault Against a Child and additional charges. The defendant allegedly sexually abused a young female relative and recorded and shared it on Snapchat.
Davis, J. Collins 19 Appearance	Eric McKenzie	Charged with Attempted Murder in the second-degree and additional charges. The defendant allegedly attacked another inmate at Rikers Island on December 13, 2021, causing him to suffer brain damage and seizures.
Conway, C. Busching 14 Motion	Jamie Sanchez	Charged with first-degree Course of Sexual Conduct Against a Child and additional charges. Between 2015 and 2020, the defendant allegedly

		sexually abused two young girls at a daycare where he worked.
Kamens, E. Morales 96 COC	Sheldon Johnson	Charged with two counts of first-degree Murder and additional charges. The defendant allegedly fatally shot Collin Small inside an apartment on Summit Avenue on March 5, 2024, cut up his body, and tried to hide the remains.

ADA Judge Part #	Defendant Name	Case Details
Wichman, T. Stone 27 Motion	Dimone Fleming	Charged with first-degree Murder and additional charges. On November 26, 2022, the defendant allegedly murdered her two children, ages three-years-old and eleven months old, by repeatedly stabbing them with a sharp object. Their bodies were found in the bathtub of their home.
Wichman, T. Stone 27 Motion	Gloria Asamoah	Charged with first-degree Murder and additional charges. The defendant, on December 18, 2023, allegedly asphyxiated her two young children.
Newell, S. Stone 27 COC	Lynija Eason	Charged with second-degree Murder and additional charges. The defendant allegedly caused the death of her 6-year-old daughter by hanging her by her wrists in a closet and repeatedly striking her with a hard object.
Namani, B. Isales 77 Appearance	Vladimir Lopez German	Charged with second-degree Murder and additional charges. On April 18, 2024, the defendant allegedly stabbed Dominic Cruz Aguilera to death after a fight over a parking space.
White, C. Steed 71 Appearance	Wayno Recio Dreshawn Lucas	Charged with two counts of Attempted Murder and additional charges. On July 16, 2024, at approximately 10:00 p.m., the defendants acting in concert allegedly shot two boys, ages 12 and 13, inside a McDonalds on White Plains Road.

Davis, J. Yearwood TRP Appearance	Anthony Taveras- Morales	Charged with second-degree Arson and second-degree Assault and additional charges. On December 17, 2024, the defendant, who is incarcerated at Rikers Island, allegedly lit a fire in his cell. He then allegedly attacked two responding CO's by slashing their hands with a sharp object.
Nunez, V. -- SCA Appearance	Casmine Aska	Charged with Predatory Sexual Assault Against A Child and additional charges. On February 27, 2025, the defendant allegedly assaulted a 15-year-old girl in the elevator by punching her. When the doors opened, he then allegedly dragged her to a stairwell and sexually assaulted her.
Kamens, E. Collins 19 Hearing & Trial	Christian Blanco Mejia Jhonathan Diego	Charged with second-degree murder, Attempted Murder in the second-degree and additional charges. On December 28, 2022, the defendants, acting in concert, allegedly shot, and killed Gregorio Alvarez and wounded three others near Marmion and East Tremont Avenues.
Dolan M. Isales 77 Motion	Dynus Saxon	Charged with second-degree Murder and additional charges. On November 10, 2024, inside 384 Grand Conours, the defendant allegedly killed Kadeem Grant, 35, by stabbing him in the neck and chest.
Tripp, K. Isales 77 Motion	Kenneth Lester Floyd	Charged with second-degree Grand Larceny and additional charges. The defendant allegedly fraudulently obtained the property rights to a house owned by a 70-year-old man and illegally collected rent subsidies from the City of New York
Sizemore, J. Morales 96 Motions	Kenny Victoria	Charged with Attempted Offering a False Instrument in the first degree, second-degree Assault, and additional charges. The defendant, an NYPD Officer, allegedly falsified an accident report in one incident, and hit a defendant on the head with his radio during an arrest which required stitches.

ADA Judge Part # Status	Defendant Name	Case Details
Ambrosi, A. Isales 77 Sentencing	Dayshawn Bannister	Pleaded guilty to Attempted Murder in the second-degree and additional charges. The defendant stabbed Cheddie Defrietis in the head with a knife on an MTA bus puncturing his brain.
