ADA Judge Part # Status	Defendant Name	Case Details
Dolan, M. Roberts 32 Appearance	Franciso Deleon	Charged with second-degree Murder, first-degree Robbery, and additional charges. On October 16, 2024, the defendant acting in concert with three others, allegedly robbed Ali Flores and then shot and killed him inside a building on Westchester Avenue.
Gibson, T. Morales 96 COC	Kendall Felix	Charged with third-degree Bribe Receiving, first-degree Promoting Prison Contraband and additional charges. The defendant, a Correction Officer at Rikers Island, allegedly accepted a \$3,000 bribe in exchange for providing contraband worth \$15,000 which included cigarettes and cellphones.
Castro, A. Fabrizio 18 COC	Skydajah Patterson	Charged with second-degree Murder and additional charges. On March 24, 2024, inside an apartment on Westchester Avenue, the defendant allegedly struck her mother Selma Mclean on the head with a pot killing her.

Wichman, T. Busching 14 COC	Derick Colon	Charged with Predatory Sexual Assault Against a Child and additional charges. The defendant allegedly sexually abused a young female relative between January 19 th and January 24 th , 2024, recorded it and shared it on Snapchat.
Miras, J. Clancy 28 Appearance	Jayden Rivera	Charged with first-degree Murder and additional charges. The defendant allegedly killed his father, his father's girlfriend, and their 5-year-old son in an apartment in Mott Haven on November 26, 2023 by stabbing them to death.
Miras, J. Morales 96 Motion	Lamont Wilson	Charged with second-degree Murder and additional charges. On December 6, 2024, the defendant allegedly stabbed Britney Webb, killing her.
Namani, B. Yearwood TRP Appearance	Rahul Cuya Terrence White Richard Santiago	Charged with first-degree Murder, second-degree Murder, first-degree Arson, and additional charges. On May 16, 2022, the defendants in concert allegedly kidnapped Nikki Huang and Jesse Parrilla, shot them execution-style, and left their bodies in a burning car.

ADA Judge Part #	Defendant Name	Case Details
Newell, S. Stone 27 COC	Lynija Eason	Charged with second-degree Murder and additional charges. The defendant allegedly caused the death of her 6-year-old daughter by hanging her by her wrists in a closet and repeatedly striking her with a hard object.

Baughman, R. Michael 27 COC	Tajanhae Brown	Charged with Attempted Assault in the first-degree, second-degree Assault, and additional charges. The defendant allegedly caused her young daughter to become ill by giving her an overdose of prescription medication to treat epilepsy.
Namani, B. Park 77 COC	Vladimir Lopez German	Charged with second-degree Murder and additional charges. On April 18, 2024, the defendant allegedly stabbed Dominic Cruz Aguilera to death after a fight over a parking space in front of 1605 Inwood Avenue.

Dolan M. Isales 77 Motion	Dynus Saxon	Charged with second-degree Murder and additional charges. On November 10, 2024, inside 384 Grand Concourse, the defendant allegedly killed Kadeem Grant, 35, by stabbing him in the neck and chest.
Russo, S. Steed 71 COC	Isaac Garcia Kyshawn Johnson	Charged with Attempted Murder in the second degree and additional charges. On September 9, 2022, Garcia allegedly told Johnson to retrieve a gun for him. Garcia then allegedly went to the Pelham Parkway Houses and fired at least 13 times into a crowd. Four innocent bystanders were shot.

ADA Judge Part # Status	Defendant Name	Case Details
Miller, K. Fabrizio 18 COC	Deshaun Coleman	Charged with second-degree Murder and additional charges. On February 8, 2024, the defendant allegedly shot and killed Hasan Richburg after an argument.

Miras, J. Park 77 Motion	Sharief Bodden	Charged with second-degree Murder and additional charges. On January 13, 2025, the defendant allegedly struck Peter Forrest multiple times resulting in his death. The attack allegedly happened inside an ambulette parked near Hart Street and Castle Hill Avenue.
