ADA Judge Part # Status	Defendant Name	Case Details
Nunez, V. -- SCA Appearance	Casmine Aska	Charged with Predatory Sexual Assault Against A Child and additional charges. On February 27, 2025, the defendant allegedly assaulted a 15-year-old girl in a Co-op City elevator and dragged her to a stairwell and sexually assaulted her.
Kilcommons, M. Morales 96 COC	Dimas Cuadrado	Charged with second-degree Manslaughter and additional charges. On November 16, 2024, near Randall and Castle Hill Avenues, the defendant, while allegedly intoxicated, drove through a red light and struck another vehicle, killing the front passenger and injuring the driver.
Dicostanzo, N. Park 77 COC	Jacqueline Ratliff	Charged with second-degree Murder and additional charges. The defendant allegedly stabbed John Welgoss multiple times in the chest causing his death on May 25, 2024.

Miras, J. Morales 96 Motion	Lamont Wilson	Charged with second-degree Murder and additional charges. On December 6, 2024, the defendant allegedly stabbed to death Britney Webb inside her apartment.
Barker, G. Clancy 28 Hearing	Travis Laroc Corey Henry	Charged with Attempted Murder in the second-degree and additional charges. The defendants, acting in concert, allegedly slashed and stabbed another inmate on Rikers Island on August 3, 2023.

Morgan, D. Park 77 COC	Christopher Hunt	Charged with second-degree Murder and additional charges. The defendant allegedly slashed the throat of Eric Worell on May 26, 2024, during an argument.
Commelin, C. Lewis 77 COC	Freddy Flores	Charged with Attempted Murder in the second-degree and additional charges. On the afternoon of March 30, 2024, on East Fordham Road, the defendant allegedly fired a gun five times from across the street. A stray bullet struck a 2- year-old boy in the left hip.

ADA Judge Part # Status	Defendant Name	Case Details
Pucha, J. Collins 19 Appearance	Moussa Cisse	Charged with second-degree Assault, and additional charges. On January 24, 2023, the defendant allegedly assaulted two Correction Officers, resulting in one receiving a concussion and the other to suffer substantial head pain.

Castro, A. Collins 19 Hearing & Trial	River Jones Allan Algarin Isiah Garrett	Charged with first-degree Murder and additional charges. The defendants, acting in concert, allegedly shot Avanti Frowner on June 9, 2022, during a robbery, leading to his death.
