ADA Judge Part # Status	Defendant Name	Case Details
Commelin, C. -- SCA Appearance	Daniel Ribustello	Charged with Criminal Possession of a Weapon, Unlawful Imprisonment and Menacing. On May 1, 2025, the defendant allegedly held a knife to his mother's neck and threatened to kill her. Police responded and shot the defendant.
Dolan, M. Isales 77 COC	Dynus Saxon	Charged with second-degree Murder and additional charges. On November 10, 2024, the defendant allegedly killed Kadeem Grant, 35, by stabbing him in the neck and chest.
Sannicandro, R. Steed 71 COC	Kyshawn Johnson	Charged with Attempted Murder in the second degree and additional charges. On September 9, 2022, defendant allegedly supplied a gun to a co-defendant who went to the Pelham Parkway Houses and allegedly fired at least 13 times into a crowd. Four innocent bystanders were shot.

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>White, C. Steed 71 COC</b>	<b>Dreshawn Lucas Waynol Recio</b>	Charged with two counts of Attempted Murder and additional charges. On July 16, 2024, the defendants acting in concert allegedly shot two boys, ages 12 and 13, inside a McDonalds on White Plains Road.
<b>Namani, B. Yearwood TRP Appearance</b>	<b>Rahul Cuya Terrence White Richard Santiago</b>	Charged with first-degree Murder, second-degree Murder, first-degree Arson, and additional charges. On May 16, 2022, the defendants in concert allegedly kidnapped Nikki Huang and Jesse Parrilla, shot them execution-style, and left their bodies in a burning car.

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Kamens, E. Collins 19 COC</b>	<b>Christian Blanco Mejia Jhonathan Diego</b>	Charged with second-degree Murder, Attempted Murder in the second-degree and additional charges. On December 28, 2022, the defendants, acting in concert, allegedly shot, and killed Gregorio Alvarez and wounded three others.

<b>ADA Judge Part # Status</b>	<b>Defendant Name</b>	<b>Case Details</b>
<b>Ambrosi, A. Steed 71 Motion</b>	<b>Charles Vilson Elizabeth Allen Marlon Laronde</b>	Charged with first-degree Criminal Sale of a Firearm and additional charges. The defendants acting in concert between June 21, 2023, and April 24, 2024, allegedly purchased guns from out-of-state, brought them to a Bronx autobody shop, and removed the serial numbers. Seventeen firearms were allegedly sold to an undercover police officer.
<b>Miras, J. Park 77 COC</b>	<b>Sharief Boddien</b>	Charged with second-degree Murder and additional charges. On January 13, 2025, the defendant allegedly killed Peter Forrest by striking him multiple times inside a parked ambulette.
