Anis, M. Hornstein 96 Hearing and Trial	Jetsy Rodriguez	Charged with second-degree Manslaughter and additional charges. The defendant was allegedly speeding when he struck and killed Christian Castelan at East 172nd Street and Metcalf Avenue in the Soundview Section.
