Vega, J. Hornstein 96 Appearance	James Walker	Charged with second-degree Murder, first-degree manslaughter and second-degree criminal possession of a weapon. On November 9, 2024, in front of 609 Oak Terrace, the defendant allegedly fired multiple rounds from a 9MM pistol at Xavier Navarez, killing him.

Wichman, T. Busching 14 Decision on Huntley Hearing	Derick Colon	Charged with two counts of Predatory Sexual Assault Against a Child, two counts of Criminal Sexual Act in the First Degree, three counts of Sexual Abuse in the First Degree and Endangering the Welfare of a Child. On or about and between January 19, 2024 and January 21, 2024 the defendant allegedly sexually abused a 4-year-old

		girl, recorded the abuse and shared the video on social media.
McHale, S. Bowen 17 Decisions on Motions	Kenneth Siriboe	Charged with first-degree Rape, first degree Sexual Abuse, Robbery and additional charges. On September 28, 2025, the defendant allegedly raped a 36-year-old woman in the stairwell of her building in the Norwood section, and robbed her.
Suminski, G. Clancy 28 Motions	Shaun Pyles	Charged with second-degree Murder and first-degree Manslaughter. The defendant allegedly fatally stabbed Tyquan Pleasant with a knife on March 24, 2023, following a dispute over loud music. Victim and defendant were neighbors.
DiCostanzo, N. Morales, C. ATI Motions	Betty Cotto	The defendant, along with two male co-defendants are charged with second-degree Murder and additional charges for fatally shooting William Alvarez on the D train at Grand Concourse and east 182nd Street on February 23, 2024.
McGraw, J. McCormack 22 Motions	Anyelo Velez Rodriguez	Charged with second-degree Manslaughter and additional charges. The defendant, on February 11, 2019, was allegedly driving his BMW at 130 MPH when he crashed into a vehicle pileup on the Cross Bronx Expressway, killing two people- Jaquan Cesar who exited his own car to assist victims, and Richard Lue who was behind the wheel of his own vehicle.
Smith, M. Busching 14 Motions	David Mosley	Charged with Aggravated Cruelty to Animals and Torturing and Injuring Animals. The defendant allegedly killed a cat and posted images of the dead animal on social media sometime between October 11 and October 16, 2025, inside his apartment.
Lucchese, T. Bowen 17 Appearance	Joshua Brito	Charged with first-degree Assault and additional charges. The defendant was allegedly operating a boat without a license with 22 passengers aboard when it exploded and caught fire, injuring two

		passengers near the coast of Hart Island and City Island, on June 7, 2025.

Strout, N. Goldsmith 33 Appearance	Richard Shaw	Charged with Attempted Murder in the second-degree, Assault, Attempted Robbery and additional charges. The defendant got into a verbal dispute on the train which then escalated into a physical altercation on the platform during which the defendant allegedly stabbed Khali Bey multiple times. The defendant then allegedly assaulted Zadkiel Toro who was attempting to call 9-1-1.
Suminski, G. Lopez, L. SCA	Jadore Reid	The defendant is charged with murder, manslaughter and criminal possession of a weapon. He allegedly shot 21-year-old Assam Alshaif in the head on March 26, 2026, causing his death.
Gibson, T. Judge: Part: SCA	Adrian Houlder Tarik Hawkins	The defendants, Correction Officers at Rikers Island, allegedly used OC spray, also known as pepper spray on inmates in a manner which was in violation of DOC guidelines, between June 15 and October 21 of 2024. They are charged with Official Misconduct and Falsifying Business records.
Strout, N. Goldsmith 33 Appearance	Richard Shaw	Charged with Attempted Murder in the second-degree, Assault, Attempted Robbery and additional charges. The defendant got into a fight in Prospect Avenue subway station during which he allegedly stabbed Khali Bey multiple times. The defendant then allegedly assaulted Zadkiel Toro who was attempting to call 9-1-1.
Leo, M. Stone 27 Conference	Ramon Reyes	Charged with first-degree Murder and additional charges. The defendant allegedly broke into the home of his children's mother, stabbing her multiple time and fatally stabbing his girlfriend's

		mother. The couple's two sons were present in the apartment during the April 6, 2025, attack.
