Gibson, T. Isales 33 Closing Arguments	Omar Habib	Charged with second-degree Strangulation and additional charges. The defendant, an NYPD officer, allegedly placed an illegal chokehold on someone he was arresting causing the man to lose consciousness in the Eastchester section on July 29, 2023.
Suminski, G. Clancy 28 On Trial	Shaun Pyles	Charged with second-degree Murder and first-degree Manslaughter. The defendant allegedly fatally stabbed Tyquan Pleasant with a knife on March 24, 2023, following a dispute over loud music. Victim and defendant were neighbors.
Fiorenza, V. Busching 14 Decision on Motions Bail Application	Emanuel Jasiri	Charged with second-degree Murder, first-degree Manslaughter and additional charges. The defendant is accused of fatally shooting Ricardo Bygave in front of a bodega on Bronxwood Avenue on April 2, 2026.
Smith, M. Busching 14 Sentencing	David Mosley	Convicted of Aggravated Cruelty to Animals. The defendant killed a cat inside his apartment and posted images of the dead animal on social media sometime between October 11 and October 16, 2025.

Gibson, T. SCA	Jayden Mendoza	Charged with two counts of Attempted Murder. The defendant is accused of driving a vehicle directly toward two NYC police officers who were conducting a traffic stop in front of 382 E. Fordham Road on June 21, 2026.
Miras, J. Clancy 28 Appearance	Jayden Rivera	Charged with first-degree Murder and additional charges. The defendant allegedly killed his father, his father's girlfriend, and their 5-year-old son in an apartment in Mott Haven on November 26, 2023, by stabbing them to death.
