McGraw, J. Yearwood TRP Sentencing	Jayson Dargan	On May 8, 2026, the defendant pleaded guilty to first-degree Manslaughter. On or about and between October 22, 2023 and November 1, 2023, he struck his brother in the head multiple times with a hard object,

		causing his death, inside their apartment at Concourse Village East.
Miller, K. Hornstein 96 Defense to Submit Psychological Report	Dionicio Cano Vicario	Charged with second-degree Murder and first-degree Manslaughter. The defendant is accused of stabbing his 32-year-old cousin to death inside their home on Selwyn Avenue on January 9, 2025.
Suminski, G. Clancy 28 Certificate of Compliance	Muhammad Aadil Ronei Harris	Charged with second-degree Murder and additional charges. The defendants acting in concert with one another, allegedly killed and dismembered Lutalo Henderson after a dispute and transported his remains in a shopping cart on a Metro North train to Yonkers sometime between July 27th and August 5, 2024.

Ward-Willis, A. SCA	Jose Bencosme	Charged with Assault and Harassment. Defendant allegedly assaulted two EMS workers at 1889 Sedgwick Avenue on April 9, 2026.
Newell, S. Stone 27 Appearance	Lynija Eason	Charged with second-degree Murder and additional charges. On May 25, 2023, the defendant allegedly caused the death of her 6-year-old daughter by hanging her by her wrists in a closet and repeatedly striking

		her with a hard object inside their apartment on Washington Avenue.

On January 8, 2025, the defendants acting in concert, allegedly shot at a group of people on East Tremont Avenue in the Mount Hope section.

On December 28, 2022, the defendant, allegedly acting in concert with another, fired into a crowd of people attending a vigil on the corner of Marmion Avenue and East Tremont Avenue, killing Carlos Gonzalez and wounding three others.

Rosen, J. Rodriguez 18 Appearance	Victor Martinez	Charged with first-degree Robbery and additional charges. The defendant allegedly stole \$100,000 worth of jewelry from a store on Fordham Road on March 5, 2024.
