ADA Judge Part # Status	Defendant Name	Case Details
Jacobson, S. Morales 96 Motions	Daquan Jackson	Charged with Manslaughter. On August 4, 2024, the defendant allegedly struck Benjamin Bernal in the head, causing the victim to fall backward and hit his head on the pavement in front of 7 W. Moshulu Parkway North. Bernal died from his injuries on September 17, 2026.
Horzempa, D. An 22 Trial	Ira Shane	Charged with second-degree Murder and related charges for allegedly stabbing Sergio Garcia to death in front of 1355 College Avenue on New Year's Day 2023.

Breslin, J. Yearwood TRP Sentencing	Edwin Rios	Pleaded guilty to Attempted Murder in the second degree on June 1, 2026. In a random attack the defendant repeatedly stabbed a 75-year-old woman inside an elevator at 2066 Morris Avenue on March 31, 2024.
Mairs, M. Bowen 17 Sentencing	William Jones	Defendant pleaded guilty to second-degree Rape. Jones, then a teacher at a Bronx Charter School, repeatedly raped a 13-year-old student inside her home between April 29, 2025, and June 2, 2025.

Dicostanzo, N. Rodriguez- Morick 29 Trial	Francisco Bengochea	Charged with second-degree Murder and Manslaughter. Defendant is accused of fatally shooting Melvin Urena on Melrose Avenue on Saturday, July 2, 2022.
Collins, T. Yearwood TRP Conference	Ahmet Gashi	Charged with second-degree Murder and additional charges. On December 31, 2006, after being ejected from a bar, the defendant allegedly got into his car and ran over Kemal Kolenovic. The defendant fled to Kosovo and was extradited to the U.S. on December 13, 2024.
Mura, S. Rodriguez, D. 70 Appearance	Christopher Joseph	Charged with Attempted Murder and Robbery. On March 22, 2025 the defendant allegedly stabbed the victim over 20 times and stole in excess of \$5,700 from her inside her apartment on East 225 th Street.

Kamens, E. Mitchell 11 Sentencing	Kareem Reid	Found guilty of first-degree Manslaughter after a jury trial. The defendant was accused of cheating during a game of dice in front of 1133 Boston Road and shot a man in the thigh, striking an artery, killing him.
