Horzempa An 26 Trial	Ira Shane	Charged with second-degree Murder and related charges for allegedly stabbing Sergio Garcia to death in front of 1355 College Avenue on New Year's Day 2023.
Flanders Yearwood TRP Appearance	Isaiah Thompson	Charged with assaulting an MTA Officer. While standing on SB platform at the Whitlock Avenue #6 street station, Defendant is alleged to have reached into the conductor's window striking her in the face causing two lacerations.
Jamelo Goldberg 77 Conference	Sheydon McLean Orville Berry	Defendants are variously charged with second-degree Manslaughter, Reckless Endangerment and Leaving the Scene of an Accident in connection with a hit-and-run collision at the intersection of Givan Avenue and Eastchester Road on November 30, 2024 that killed Dwight Downer.

Collins Yearwood TRP Conference	Isaiah Vasquez	Charged with second-degree Murder and related charges. On November 5, 2021, the defendant acting in concert with another allegedly shot Almalik Lee to death inside an apartment at 1290 Rodman Place.
Shaw FB Appearance	Jaime Sanchez	Charged with Grand Larceny, Falsifying Business Records and related charges. Defendant operated a daycare and allegedly fraudulently received more than \$29,000 in payments from the NYC Administration for Children's Services for two children he listed as attending the daycare who in fact did not.

Kline Stone 27 COC	Junior Perez Diaz	Charged with second-degree Murder and Kidnapping. The defendant and the victim were intimate partners. Defendant is accused of killing the victim inside their Morris Avenue apartment, placing her body in a suitcase and dumping the suitcase along the Saw Mill River Parkway on March 2, 2025.

S. Sizemore Collins 19 Appearance	Jose Aguilar	Charged with Grand Larceny. Defendant is accused of taking \$4,000 from two individuals with the promise of providing car insurance. Victims received notices from the NYS DMV that their insurance coverage had lapsed.
Dolan Collins 19 Appearance	Terrell Lloyd	Charged with second-degree Murder and additional charges. The defendant allegedly shot and killed Laquai Dash on the grounds of P.S. 157 on March 7, 2025
Namani Hortenstein 96 Appearance	Raul Camuez Marcus Toolsie	Toolsie is charged with second-degree Murder and Camuez is charged with Criminal Possession of a Weapon, in connection with the fatal shooting of John Medina on April 22, 2025
