Lucchese, T. Bowen 17	Joshua Brito	Charged with first-degree Assault and additional charges. The defendant was allegedly operating a boat without a license with 22 passengers aboard when it exploded

Strout, N. Clancy 28 Appearance	Emmanuel Awah Elias Afflada	Charged with Attempted Murder in the second-degree and additional charges. The defendants acting in concert, allegedly punched, kicked, and stabbed a man near East 182nd Street and the Grand Concourse in the Fordham Heights section on January 1, 2024.
Conway, C. Bowen 17 Possible Disposition	William Jones	Charged with second-degree Rape and additional charges. The defendant, a math teacher, allegedly raped one of his 16-year-old students multiple times between April 29, 2025 and June 2, 2025.
Sosa, C. Bowen 17 Appearance	Xavier Chapman	Charged with first-degree Rape and additional charges. The defendant allegedly sexually assaulted a woman sitting on a park bench at Washington Park on September 17, 2025.

Castro, A. Park 32 Decision on motion	Andrew Ansah Jordan Williams	Charged with second-degree Murder and additional charges. The defendants allegedly stabbed to death Angel Mendoza in concert with two juvenile defendants inside Williamsbridge Oval Park in the Norwood section on August 5, 2025.

Burim, N. Clancy 28 Appearance	Diego Ortega	Charged with second-degree Murder and additional charges. The defendant allegedly stabbed Baraquiel Castelan to death with a knife after the two got into an argument on East 153rd Street on February 3, 2024.
Irace, P. Fabrizio 18 Hearing and Trial	Taveon Hargrove Wayne Lucas	Charged with Attempted Murder in the first degree and additional charges. On May 24, 2025, on St. Peter's Avenue, in the Westchester Square section, the defendants allegedly severely beat and robbed NYPD Officer Chowdhury Nafees who suffered head trauma, fractures to his left orbital bone and right cheekbone.
