## **BRONX DISTRICT ATTORNEY DARCEL D. CLARK ANNOUNCES HIRING OF 35 ASSISTANT DISTRICT ATTORNEYS**

Bronx District Attorney Darcel D. Clark today announced the appointment of 35 new Assistant District Attorneys to the Bronx District Attorney's Office.

District Attorney Clark said, "I am excited to announce our new class of Assistant District Attorneys, who come to us from across the nation as well as New York City. This driven and diverse group of lawyers will undergo months of training to prepare them for serving the people of the Bronx by 'Pursuing Justice with Integrity.' With this new class, and our current Assistant District Attorneys, we will continue to do all we can to keep the public safe."

The new class is made up of 19 females and 16 males; 14 are people of color. The new Assistant District Attorneys undergo three months of training that includes classroom lectures on criminal court practice and professional responsibility, courtroom observation, workshops and experiential courtroom training.
